2. Data We Collect

- **Verification data**: government-issued ID, proof of address (where required).
- Transaction data: order history, amounts, payment confirmations (screenshots, M-Pesa references).
- Technical data: device type, browser, IP address, cookies, log data.
- **Support data**: tickets, messages, and communications with us.

3. How We Use Your Data

We process your data for the following purposes: - To provide and operate the BuyTap platform (order creation, pairing, confirmations).

- To verify identity and comply with **Know Your Customer (KYC)/Anti-Money Laundering (AML)** requirements.
- To prevent fraud, abuse, and unauthorized access.
- To improve platform performance, security, and user experience.
- To comply with legal obligations in the **United States** and **Kenya**.
- To communicate updates, support, and service notices.

4. Legal Bases for Processing

We rely on the following legal bases: - Contract necessity: to provide services you sign up for.

- **Legal obligation**: to comply with AML/KYC, tax, and other regulations.
- Legitimate interests: fraud prevention, platform improvement.
- Consent: for marketing communications and optional analytics cookies.

5. Sharing of Data

We may share your data with: - Service providers: hosting, analytics, email, SMS providers.

- Payment operators: e.g., M-Pesa, only for processing and verification.
- Authorities: when legally required in the U.S. or Kenya.
- **Affiliates**: within BuyTap group companies for operational purposes.

We never sell your personal data.

6. International Data Transfers

As a U.S. company operating in Kenya, your data may be stored and processed in both regions. We use **secure cloud providers** and apply safeguards consistent with Kenyan Data Protection Act (2019) and relevant U.S. privacy standards.

7. Data Retention

- KYC/AML data: kept for 5 years after account closure (regulatory requirement).
- Order and transaction logs: kept for 12–24 months.
- General account data: retained until you delete your account, or as required by law.

8. Your Rights

You have the right to: - Access and request a copy of your data.

- Request correction of inaccurate data.
- Request deletion (subject to legal retention).
- Withdraw consent for optional data uses.
- Object to certain processing.
- File a complaint with the **Kenya Office of the Data Protection Commissioner (ODPC)** or the relevant U.S. authority (e.g., FTC).

We use: - Essential cookies: to keep you logged in and secure.

- Analytics cookies (optional): only with your consent.
